Terms and Conditions

Eligibility

- Land must be within the WIWCD
- The water body must normally be used for watering of livestock and livestock must be excluded from drinking directly from water source
- Lake shore is excluded from this program
- Allow for at least a thirty (30) foot buffer strip between water and livestock
- The WIWCD will pay 100% of the cost of the project with the exception of installation of fence. Landowner responsible for the installation of fence
- One application per landowner per year, dependant on Board approval

Roles and Responsibilities

The Applicant Shall:

1. Design and build the project in cooperation with District staff and/or other partner organizations such Manitoba Habitat Heritage Corporation (MHHC)
2. Be responsible for required maintenance following the completion of the project and agree to leave the project in place for a minimum of ten (10) years. After ten years, all materials purchased and/or installed will become the property of the landowner
3. Grant consent of entry to the District, its agents, servants, and/or employees with the necessary equipment for inspection and advertisement of the project
4. Not alter, remove, or modify the project without written consent of the District
5. Indemnify and save harmless the WIWCD, their agents, engineers, servants, and/or employees from any liability which may result from this project
6. Be responsible for the remaining 50% and all costs (plus GST) over the Conservation District maximum of \$1,000.00

The WIWCD Shall:

1. Provide technical advice, funding and project supervision

General Information

The annual projects resulting from this program are subject to available annual funding. The Conservation District will determine application priorities in consultation with Sub District members and District staff. All projects must be approved by the Conservation District prior to construction and/or installation.

I hereby declare that I have read and understand the Terms and Conditions of the Riparian Management Program and agree to abide to the said Terms and Conditions if my application is approved and cooperate with the WIWCD in completing and maintaining the project as outlined.
